About the Company

NCC Ltd (NCC), established in 1978, is a listed construction company in India. The company was founded as a partnership firm and converted into a limited company in 1990. NCC was formerly known as Nagarjuna Construction Company Limited.

The company is engaged in the construction activities in the sectors of buildings & housing, roads, electrical, water & environment, irrigation, railways, power, metals and mining.

Business Operations

NCC is involved in the construction, engineering and infrastructure development activities. NCC along with its subsidiaries and associates, is engaged in the infrastructure sector and undertaking turnkey EPC contracts. NCC is an ISO 9001: 2015 certified organization.

NCC has employed more than 5901 people, spread across head office, regional offices and various sites.

Some of the key projects of NCC includes:

- Construction of National War Memorial in Delhi comprising of four concentric circles
- Construction of Nalanda University, Bihar
- Construction of Airport at Agartala, Tripura
- Projects awarded by Singareni Collieries Limited
- Construction of airports and other infrastructure development works at six locations for Defence department in Arunachal Pradesh

Few Notable Highlights of NCC

- In FY22, NCC received order inflow of ₹ 121.58 bn. The group order book stands at ₹ 393.61 bn as at the end of the year.
- In FY22, the company reported 37% growth in revenues compared to FY21 with PAT of 4.9% and debt-equity ratio of 0.20.
- In FY22, the finance cost remained at ₹ 4.6 bn despite 37% growth in revenues, due to the decrease in borrowings, mobilization advance and decrease in cost of borrowings.
- The investments decreased by ₹ 0.91 bn, during FY22, primarily on account of divestment of investment of ₹ 0.50 bn made in NCC Vizag Urban Infrastructure Limited.
- Many marquee projects of National Importance are under execution.
