Simple measures such as using dustsuppression solutions, enclosure of transfer houses and geo coir matting have gone a long way in building mines that are sustainable and 5 Star Rated.

While transitioning towards greener and cleaner sources of energy, we are conscientiously monitoring greenhouse gas (GHG) emissions and energy consumption, which has enabled a reduction of our total per tonne GHG emission intensity by 24% in the last decade. Aligned with the national goal of creating carbon sinks, NMDC conducts





afforestation drives, ecological monitoring and is collaborating with State Forest Departments for Green Action Plans. Efficient use of resources. minimizing waste, and ensuring biodiversity conservation have been serving our commitment to meet the Sustainable Development Goals set for the industry and the nation.
